

HOTEL AT SHERIFF'S SALE.

AT TOWNTOWN'S BIG HOTEL SOLD FOR LESS THAN \$6,000.

Property Comprises a Three-story Brick Building and a Big Plot of Ground on Eatontown's Most Prominent Business Corner.

Thomas Elwood Snyder's big hotel at Eatontown went under the hammer at sheriff's sale on Monday.

The property brought only the face of the mortgage and the back interest, less expenses of the sale.

The sale of the property by the sheriff was made to satisfy a mortgage on a hotel held by the estate of the late James Holmes Hendrickson of Red Bank.

This mortgage was for \$50,000. There was some back interest due, as well as the mortgage interest, and there were two years' unpaid taxes.

The costs of the sale added to come out of the property. The hotel was bought in by the estate of J. Hendrickson for the amount of the mortgage, interest, taxes and costs of the sale.

This was a trifle less than \$6,000.

Besides the mortgage held by the Hendrickson estate there was another mortgage on the hotel property. This is a second mortgage of \$5,000 and is held by the Lembeck & Betz law company of Jersey City.

WORD FROM SUNNY ITALY.

RED BANK SOLDIER TELLS OF HIS EXPERIENCES THERE.

Michael Christo, a Native of Greece, Who Conducted the Columbia Restaurant, Visited His Relatives in Salonica While on a Furlough.

Michael Christo of Red Bank, a former proprietor of the Columbia restaurant who is now a sergeant with the American forces in Italy, has written a letter to the Register telling of his experiences. He writes as follows:

"I've been thinking of you quite often and always wanted to write to you, so busy you are."

"As you will note I am in 'sunny Italy' where the sun shines, but not often. This is probably a nice place in summer, but right now the rainy season is on and the other day I thought we would be able to sail right from our front door to America."

"The town we are in has a population of about 70,000 people and is the home of the famous Borjano Hat Company. A greater part of that plant, however, was closed during the war and used for warehouses and hospitals. The owner is a man who rose from the ranks and is a very generous man as well as a patriotic fellow."

"There are not many historical sights here, but in Verona, the town I was in before coming here, I found many interesting things, such as cathedrals, old arenas built during the time of Christ, the old site of the Shakespearean story of Romeo and Juliet, and what is said to be the tomb of Juliet is still intact and beautiful. The old town is surrounded by a great wall of stone and every here and there is an old fort. These forts were even used in this great war as lookout towers to give warning of an air raid."

"I have been in Italy since August, 1918, and have been around quite a bit. Just recently I made a trip to Salonica, Greece, to visit my brothers and sisters. I found them all well and very glad to see me after twelve long years. I enclose a picture of myself in uniform."

"Well, I must close, so give my best wishes to my friends, especially to George Hance when he gets back, and I hope to see you in Red Bank real soon."

FISH MEN COMBINE.

A National Organization Formed Last Week in New York.

Last week a national fishery association was formed in New York to consist of fishermen and distributors of fish. Scout steamers, hydroplanes and wireless are to be used to notify fishing steamers of the approach of fish and of the whereabouts of the schools of fish of migratory habits.

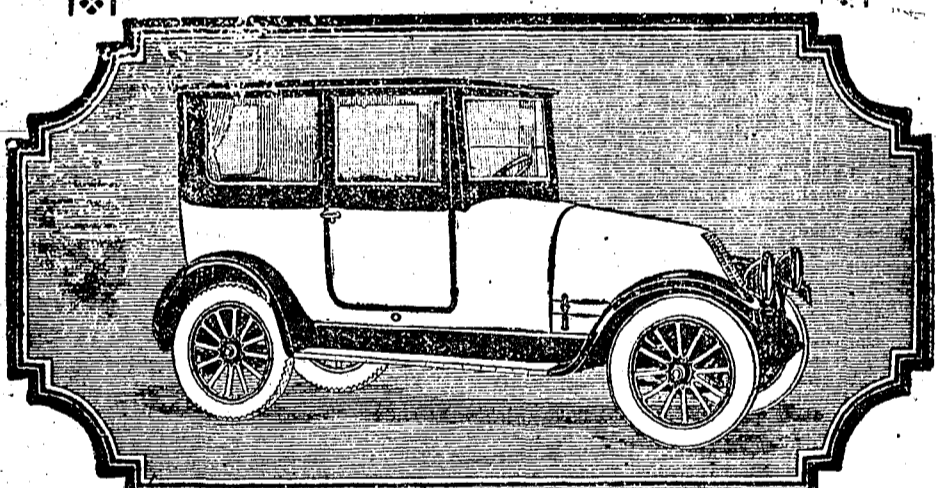

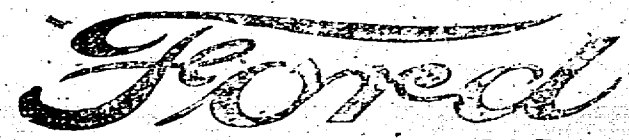

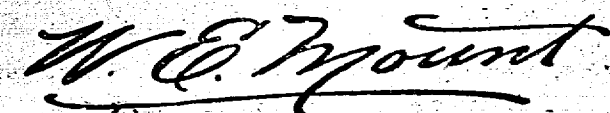

TOWN TALK.

Several years ago Arthur Holtsen of Long Branch started an "Own Your Home" campaign in that town. The campaign resulted in a considerable number of new homes being established in Long Branch.

There are many reasons why every family should own its own home. Paying rent is like throwing money in a rat-hole. The family pays the rent and at the end of ten years all the family has to show for the money is a bunch of rent receipts.

The man who builds a house for rent must make a profit on the investment and the tenant pays this profit in rent. When the family owns a house of its own, they make this profit themselves.

The man who buys a house, even if he has not previously laid by a dollar, makes money on buying a home instead of continuing to pay rent.

The United States government has now taken up this campaign of inducing every citizen to own his own home.

Every town and every locality should encourage in every possible way the building and ownership of homes by the families who occupy them.

Red Bank should also encourage everything which will make the town more attractive and which will not only add to the number of home owners in the town but which will add to the pleasure and satisfaction of living in the town and in the surrounding neighborhood.

This campaign which is being waged in many cities and towns to increase the number of those who own their own homes, and the campaign of the United States government to urge the ownership of homes for the sake of the children and as a matter of patriotism, ought to bear fruit.

are trying to get homes of their own and local governments should give every encouragement possible.

No man is too old to think about getting a home of his own, even if he has never made a start in that direction. Every young man and young woman should likewise make a start toward the ownership of a home.

Last summer and last fall, when Governor Walter E. Edge was running for United States senator, one of the important questions which was discussed with the government ownership of railroads and other public utilities.

Governor Edge's statement that he would keep an open mind on this subject was generally regarded as political "hunk."

I don't imagine that Governor Edge's bank of last fall on this question got him one more vote than he would otherwise have got or lost him one vote that he might have got.

Under Governor Edge's administration, for the first time since the civil war, a state tax was imposed. In addition to this state tax, new kinds of taxes were devised, which came out of the people directly or indirectly.

For years these corporations had been making great profits and the public utilities commission never made a move toward reducing the price of their services.

These contracts had been made by the public service corporations in order to get franchises from the people. If the contract was invalid on the one side, as the public utility commission decided, then it would seem that the other side of the contract was invalid also.

The public utility commission should be abolished, for the people get better treatment and better service when the commission was created than they have received since the public service law was passed.

All public utilities should be owned by the people; but if there are to be public utility commissioners at all they should be elected by the people.

FAITHFUL READERS OF BIBLE

Family of Ezra Stiles Certainly Should Have Been Thoroughly Conversant With Good Book.

Ezra Stiles was president of Yale college from 1777 to 1793. He was, says the Kansas City Star, one of the leading men of those times, meeting on terms of social equality whoever was active in affairs—Washington, Adams, Webster, Putnam, Franklin, Rochambeau and others. Among other labors Ezra Stiles kept a meticulous diary, which has been edited and condensed (into three volumes) by Dr. Franklin B. Dexter of Yale. The diary is staggering in its detail so that the wonder is that its writer could find time for any other occupation. For instance we find that Stiles was an inveterate reader of the Bible. That he also imposed this task upon the members of his family may be gathered from the following excerpt:

"July 31, 1793—My daughter, Ruth, from 1775 to 1793 or in 18 years, has read her Bible 14 times through; and my Gr-D, Eliza, net, 11, has read it through five times. Emilia has lost her minutes, but has probably read it a dozen times & more, for she read it once a year for several years after 1775. My other children have read it sundry times. May God bless the Reading of this holy Book to them. My wife died in 1775. She read through the Bible five times the last four years of her life, once in about 9 or 10 months. Keziah died 1785; she read it through five times the last five years of her life. Besides reading in Course privately in my Study, I read thro' the Bible in my Family at Morning Prayers from 1760 to 1791, eight times, or once in four years. My family have had full opportunity of being acquainted with the sacred Contents of the Bible."

Highly Ornamented Knives.

There is an interesting set of table knives, dating from the first decade of the seventeenth century, of which 14 are in the Victoria and Albert museum at London and others in Scotland, which have carved and jeweled ivory handles representing some of the royal sovereigns of England. Those in London come to an end with the somewhat unremarkable visage of James I, and one can imagine that they were, broadly speaking, fairly good likenesses. The handles are so contrived that they would not, one thinks, be uncomfortable to hold and these knives certainly have the advantage of presenting a fine object lesson in English history. The steel blades of these knives are dinned with gold at the neck.

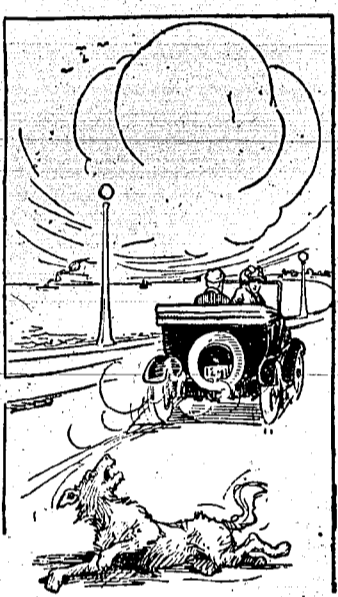
When Edith got home she didn't know whether to laugh or cry; the day's shopping with Jim had been so different from what she had expected.

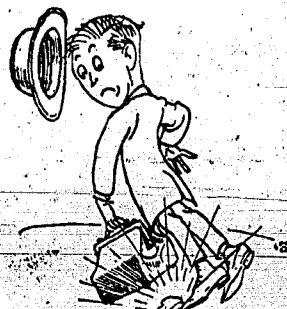
